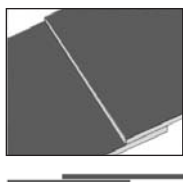

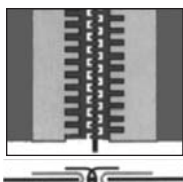

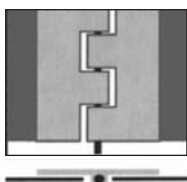
Seam Options
